Good to know: New European regulation on batteries in force since February 2024

On July 28, 2023, the European Commission published in the Official Journal of the EU the new European Battery Regulation, which replaces the old Battery Directive 2006/66/EC of 06.09.2006 and finally entered into force on August 17, 2023. After a period of six months, the regulation will be valid in all EU member states on February 18, 2024.

The transition periods provided for in the Battery Regulation are also indicated as a fixed date for the obligations of the Regulation itself and as the date of entry into force of the respective delegated acts. Theoretically, the deadline could also be later than the deadline set for the relevant requirement. However, in this article we always assume the fixed dates of the articles of the regulation.

Within the broader framework of the European Green Deal and the European Circular Economy Plan, the main objective of the new European Battery Regulation is as follows:

1. create harmonized European product standards for all types of batteries,
2. establish an efficient single European market for secondary raw materials for batteries
3. significantly reduce negative environmental impacts during production phases , use and end of life of all batteries.

In terms of content, the Battery Regulation includes in particular:

- definitions of battery categories
- “reuse” of batteries in all its forms,
- collection and recycling,
- rules relating to extended and effective liability of the producer (REP), including for battery waste management organizations such as Bebat vzw,
- reduction of the carbon footprint of batteries,
- minimum requirements for performance and sustainability (including service life),
- reuse of a percentage of recycled materials,
- removal and replacement of batteries from appliances and devices,
- safety requirements,
- provision of information to the battery user on aspects linked to the environment and safety,
- socially responsible and sustainable procurement of batteries by public authorities,
- a duty of care in the battery value chain, in particular during the extraction of raw materials.
